IN CONSIDERATION of being allowed to participate in any way in the motorsport event or activity indicated above and/or being permitted to enter for any purpose any restricted area (herein defined as any area wherein admittance to the general public is prohibited), the patron(s) and/or legal guardian(s) of the minor named below agree:

1. The parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating in the above motorsport activity or event, he/she should inspect the facilities and equipment to be used, and if he/she believes anything is unsafe, the participant should immediately advise the officials of such condition and refuse to participate.

2. I/we fully understand and acknowledge that:

a.) There are risks and dangers associated with participation in motorsport events and activities which could result in bodily injury, partial and/or total disability, paralysis, and death.

b.) The social and economic losses and/or damage, which could result from those risks and dangers described above, could be severe.

c.) These risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of others, including, but not limited to, the "Releasees" named below.

d.) There may be other risks not known to us or are not reasonably foreseeable at this time.

3. I/we accept and assume such risks and responsibility for the losses and/or damages following such injury, disability paralysis or death, however caused and whether caused in whole or in part by the negligence of the "Releasees" named below.

4. We, the parents or guardians, do for the minor child and his/her heirs, executors, administrators, and assign release, waive, discharge, and relinquish any actions or causes of action for personal injury, death, or property damage that may arise from participating in the motorsport event or activities conducted by the promoter, participants, racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, car owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners, lessees of premises used to conduct the event and each of them, their officers, agents and employees all for the purposes herein referred to as "Releasees", and agrees that under no circumstances will releasor or releasor's heirs, executors, administrators, and assigns prosecute or present any claim for personal injury, death, or property damage arising from participating in any motorsport activities conducted by releasee, whether such personal injury, death, or property damage be caused by the negligence of releasee or otherwise.

5. On behalf of the participant and individual, the undersigned parent(s) and/or legal guardian(s) for the minor participant executes this Waiver and Release.

6. All derby drivers and helpers must wear a fluorescent shirt - orange, green or yellow.

I/WE HAVE READ THE ABOVE WAIVER AND RELEASE, UNDERSTAND THAT I/WE GIVE UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGN IT WITHOUT INDUCEMENT.
